The discussions are about how good journalism can impact the social good, how innovation can facilitate the efforts with regards to the social good and how technology can contribute to the achievement of the Sustainable Development Goals (SDGs) or in general the social good.

This year's Social Good Summit coincides with the United Nations' ratification of its 17 Sustainable Development Goals. More than 7 million people from around the world voted for the goals, making the international meetups a symbolic "ringing in" of what the UN calls "the people's goals."

Kamal Malhotra UN Resident Coordinator and UNDP Resident Representative in Turkey

Kamal Malhotra assumed his positions as UN Resident Coordinator and UNDP Resident Representative for the Republic of Turkey on 8 April 2013.

Prior to this appointment (late October 2008-31 March 2013), Mr. Malhotra was the UN Resident Coordinator for Malaysia; UNDP Resident Representative for Malaysia, Singapore and Brunei Darussalam and UNFPA Representative for Malaysia.

From 1999 to 2008 he worked in UNDP's Bureau for Development Policy, New York as Senior Adviser on Inclusive Globalization (and Cluster Leader) (2002-2008), Civil Society Empowerment Adviser (2001-2002) and Senior Civil Society Adviser (1999-2000).

Before joining UNDP, Mr. Malhotra was Co-Founder and Co-Director of Focus on the Global South, (1995-1999) a global policy research organization located at the Chulalongkorn University Social Research Institute in Thailand. During this period, he was also a part-time Regional Adviser on Macroeconomic Policies and Children's Rights for Save the Children Fund (UK) for South-East Asia and the Pacific.

Prior to this, Mr. Malhotra was Director of the Overseas and Aboriginal Programme at Community Aid Abroad (Oxfam Australia), based in Melbourne, Australia from 1988 to 1995. He also served with the International Institute of Rural Reconstruction in the Philippines (1982-1988) in various positions as Research and Rural Credit Specialist, Associate Director, and Director, International Extension.

Mr. Malhotra holds an MA in International Affairs from Columbia University, New York, with a specialization in economic and political development, a Master's in Business Administration from the Indian Institute of Management, India with a specialization in finance and economics, and a BA in Economics (with Honors Degree), from the University of Delhi, India.

Mr. Malhotra is widely published with over 75 journals and other articles on the multilateral system and development cooperation. He is also the lead author or co-author of more than five books including the UNDP led Making Global Trade Work for People (Earthscan, 2003) and Globalization and the Least Developed Countries (UNDP, in cooperation with the UN-OHRLLS and the Government of Turkey, 2008). He also initiated and led Virtuous Cycles: The Singapore Public Service and National Development (UNDP, 2011) in cooperation with the Government of Singapore.

Mert Firat was born in Ankara in 1981. After graduating from high school, he went to Sweden to receive training in radio and television.

Later he moved back to Ankara and earned a Bachelor's degree in Theater from Ankara University Faculty of Language, History and Geography.

He has starred in a series of television programs and movies since 2005. He also played the lead role in the film "Love in Another Language", the script of which was written by Fırat himself along with director İlksen

Başarır. Fırat also wrote the script for the film titled "Atlıkarınca" (Merry-go-round).

Firat, who has been involved in theater for many years performing on various stages, still performs in striking shows titled "Bütün Çılgınlar Sever Beni" (All the Crazy People Love Me) and "Parkta Güzel Bir Gün" (A Beautiful Day at the Park) on the Moda Stage.

He took part in a wide range of corporate social responsibility (CSR) projects and public awareness campaigns. He also taught acting and drama classes to children in Samsun İlkadım Learning Unit within the scope of "I Read, I Play" project carried out by the Educational Volunteers Foundation of Turkey (TEGV). He contributed greatly to setting up clubs for deaf and hearing impaired people and opening sign language courses by the Educational Volunteers Foundation of Turkey. He participated panels on incestuous relationships held by Mor Çatı Women's Shelter Foundation. He played a significant role in making the issue of incest come to the forefront. He gave active support to the anti-fur campaign named "Take Off Your Fur, Wear Your Conscience" (Kürkünü Çıkar Vicdanını Giy) launched by the Bana Göz Kulak Ol Association.

Firat, who took part voluntarily in various public awareness campaigns launched by the Mother Child Education Foundation (AÇEV), the Foundation for Children with Leukemia (LÖSEV) and a variety of LGBT and youth organizations is still involved voluntarily in many different campaigns and activities.

Last but not least he played an active role in national and global activities on gender equality and violence against women. 

Afterwards, he ran various sustainable development projects in Turkey. His expert fields are sustainable development, international and public-private partnerships, regional development, governance, development management, local governments and cities, corporate social responsibility, social entrepreneurship, NGOs and civil society, international aid and funds.

Alemşah Öztürk Founder of 41?29! Digital Agency



Alemşah Öztürk graduated from Yıldız Technical University after finishing Kabataş High School. Thanks to his passion developed for the Internet when he was a student, he began his career at early ages.

In 1999 he established his first agency, Plus v.2 with his friends. Later on in his career, he worked as a Creative Director in many advertising agencies. With the development of the digital advertising industry, he quit his job on Manajans and founded his digital advertising agency 41?29! in 2007.

He won countless awards with 41?29! and also became the Co-founder of Arcademonk, Grupanya and Dijital Büro İstanbul in 2010. After 2011, he sold his majority share of 41?29! to WPP and paved the way for the agency to become a regional player.

As of 2015, he merged Grey İstanbul with 41?29! into 4129Grey, which offers services as an integrated full service advertising agency.

Engin Yılmaz

Director of GETEM (The Assistive Technology and Education Laboratory for Individuals with Visual Disabilities) and Chair of ABFA (Association of Barrier Free Access)



Engin Yılmaz was born in Ankara in 1979. He graduated from Boğaziçi University with two Bachelor of Arts degrees in Psychology and Guidance and Psychological Counseling in 2002. He graduated as the top student of the Department of Guidance and Psychological Counseling.

He earned a Master's degree in Cognitive Psychology from Boğaziçi University in 2005.

He worked as a counselor in a public high school between 2002 and 2007.

He began his PhD in Adult Education at Boğaziçi University in 2008. He successfully completed the doctoral qualifying examination and has been writing his doctoral dissertation.

He was selected as a student representative to the Disabled Students' Commission of the Council of Higher Education in 2010 and has been working in the same position since then. He offered various computer training courses including MS Word, Excel, PowerPoint, Internet for the blind and visually impaired between 2002 and 2012. He also played an active role in translating screen reader programs into Turkish. He taught iOS courses to blind and visually impaired people within the scope of Barrier Free Education Project launched in the period 2014-2015.

He also installed screen reader programs on computers used by employees working in the call centers of various institutions such as Turkish Airlines, Atlasjet Airlines, AVEA and HSBC Bank and therefore he played a key role in social integration in the workplace of blind and low vision employees. He wrote scripts to make Document Management System (DMS) of the Ministry of National Education accessible for all in 2015.

Yilmaz is one of the founders of the Association of Barrier Free Access. He played a significant role in developing an audio-based information system providing blind and vision impaired people with audible messages outlining bus station facilities and bus stop locations on the public bus network in Istanbul, designing an accessible voting system for blind and visually handicapped people, holding demonstrations among sidewalk activists for accessible streets and launching video description

programs for the first time in Turkey. He also writes for the magazine Equal, Accessible, Barrier Free Life (EEEH). He has been working as the Director of the Assistive Technology and Education Laboratory for Individuals with Visual Disabilities (GETEM) since 2007.

He still serves as the Director of GETEM, Chair of ABFA, a member of the Disabled Students' Platform, the Student Representative to the Disabled Students' Commission of the Council of Higher Education and the Co-chair of the Audio Description Association.

Serkan EmekDigital Media Systems (DMS) Service Development Group Manager, Türk Telekom Group



Serkan Emek worked as the Digital Media Services Project Manager and the Mobile TV Product Development Manager in Türk Telekom Group and he has been working as a Digital Media Product Development manager for over four years in Türk Telekom Group. He also worked as the Conditional Access Specialist and the Conditional Access Operation Manager in Digiturk in his early career. He has sixteen years of professional experience on a wide range of fields such as product development, project management and business planning. He received his PhD degree in Electronics and Communications Engineering from Yıldız Technical University.

Barrier Free Tivibu Service is a service specially tailored to the needs of blind and visually impaired people. Video description (also known as "audio description") provides narration of key visual elements, making television programs and movies accessible to blind and visually impaired viewers. Blind and visually impaired customers may also activate the talking guide feature by double tapping a button on their remote control.

Fatih Türkmenoğlu MC, TV Journalist and Producer, Author



Fatih Türkmenoğlu earned his Bachelor's degree in Psychological Counseling from Boğaziçi University and Master's degree in Human Resources Management (HRM) from New York University. He started writing in Sabah newspaper and prepared and presented the radio program "Köşebaşi" on Radio 2019. He started working as a correspondent for NTV in 1996. He has covered breaking news from across the country and around the globe and produced a wide range of television programs. He produced and hosted television programs such as "Renkler ve Sesler" (Sounds and Colors), "Sevgi İle" (With Love), "Her Mevsim Bahar" (Every Season is Spring), "Hindistan'dan Masallar"

(Stories from India) and "Yolcu" (Traveler) in four and a half years.

He participated in a wide range of trainings and conferences at CNN's headquarters in Atlanta after having been invited by CNN International. In 2001, he started to work for CNN Turk and continued preparing and hosting "Sounds and Colors". He began working as a reporter and producer for CNN Turk in 2003 and worked as a columnist for Turkish Daily News (the column's name: A Day Out in Istanbul). He was also the volunteer chief editor of the monthly media organ "B" of the Boğaziçi University Alumni Association (BÜMED).
